This Month's Message from our President

As I write this, I am out of town attending a formal Navy Match as the Statistical officer. The shooting sports is alive, lots of competitors shooting Conventional Pistol, High Power Rifle and we even have a steel challenge match.

South Bay Rod & Gun Club currently has over 3,000 members and it run by Volunteers. Board Members, Range Safety Officers, and Work Party participants. In San Diego Court Assault Weapon Law, Magazines over 10 rounds Ban, Ammunition background Checks, and Billy Club issue The judge was supposed to review this case on February 23, 2023. Outside the California area is an assault weapons laws in Washington which was just signed into law last week and is already in the courts with a challenge regarding a violation of the second amendment and Illinois has a assault weapons bill signed in Jan 2023 which was just blocked by a federal judge in the southern district as a violation of the constitution rights of citizens

Handgun Roster: Two Federal Judges ruled that the handgun roster is unconstitutional. 1st one ruled that the loaded chamber indicator, magazine disconnect and micro stamping was unconstitutional, the CA DOJ only challenged the Loaded chamber indicator and the magazine disconnect. They did not challenge the microstamping provision.

2nd one ruled that the loaded chamber indicator, magazine disconnect, microstamping and the concept that every gun that is added to the list two must come off the list was ruled as unconstitutional.
